

EXECUTIVE SUMMARY / TRANSITION STRATEGY

The operation to assist the people displaced from Ukraine to North Macedonia will be extended until the end of 2025. Through its activities, the Red Cross of North Macedonia will continue to assist the displaced population through health activities, mental health, and psychosocial support. As part of the plan the RCNM will help the most marginalized people affected by the Ukraine crisis through distribution of vouchers for hygiene items and clothing, focusing on women with children, pregnant women, single parents, and older people, particularly those with health problems or traveling alone. Protection activities as part of the response will continue until 2025 with a focus on humanitarian service points (HSP), through which food parcels will continue to be distributed, and child friendly spaces (CFS). RCNM will also focus on NSD to further strengthen its capacity to implement activities and prepare for future crises.

NEEDS ASSESSMENT AND TARGETING



Humanitarian impact of the crisis and resulting needs1

More than 80% of the people fleeing the conflict in Ukraine and arriving in the Republic of North Macedonia are women, including mothers with young children, and people over 65. These are also the most marginalized groups and most of them are unemployed and lack a stable income. Like migrants and refugees fleeing other parts of the world and transiting through the so-called Western Balkan migratory route, the people fleeing the conflict in Ukraine experience a lack of food and hygiene items, health care, education, accommodation, after school activities and lack access to the asylum/refugee protection system in the country. In total, 6,410² people fleeing Ukraine are estimated to have arrived in North Macedonia.

Unlike migrant groups who are mainly transiting through the country, people fleeing Ukraine are expected to stay in North Macedonia until the end of the conflict in Ukraine and live among the local population (accommodation is not provided by the government, so people are renting on the open market, staying with relatives or host families providing free housing). They are accepted by the local community without visible signs of impatience, prejudice and

xenophobia. Due to the registration status of most of the people coming to North Macedonia from Ukraine (not seeking asylum), they do not have free access to state provided health, mental health, psychological support services, medicines, or emergency medical treatment.

Assessment of needs is based on meetings with focus groups among people fleeing the conflict in Ukraine, meetings with associations of people displaced from Ukraine in the Republic of North Macedonia, and the results of post distribution monitoring with questionnaires as part of cash and voucher assistance (CVA) activities. The number of people fleeing Ukraine to North Macedonia is small, which allows the staff of the Red Cross of North Macedonia (RCNM) to have continuous communication and personal interaction with those among the affected people who are receiving help, such as during the distribution of humanitarian aid, at registration points, or during other activities. The operation targets mainly people with disabilities, people over 65, and mothers with young children, who are the biggest groups needing assistance among the people fleeing Ukraine. In total, the operation targets 1,300 people with humanitarian assistance. The staff monitors their satisfaction with the support that has been provided and inquires about the needs in the coming months. Their suggestions are taken into full consideration as part of project design. The assessment showed that there is a continuous need for financial assistance, support in accessing health facilities and medicine, extracurricular activities for children, venues for social interaction (child friendly spaces aligned with Movement standards³), and courses in Macedonian language.

Prioritization of needs and target groups

The RCNM provides referral to facilitate integration of displaced people from Ukraine into society and to ensure that important services are being made available by relevant institutions. Due to the registration status of most of the people coming to North Macedonia from Ukraine, they do not have free access to state provided health, mental health, psychological support services, medicines, or emergency medical treatment (this issue is being addressed by the RCNM through humanitarian diplomacy to take into account the special circumstances of people fleeing the conflict in Ukraine). The RCNM is also providing basic relief items, financial support, and activities to ensure social inclusion through child friendly spaces, extracurricular activities for children, and summer camp. All these services and support have been identified as important needs by the people fleeing the conflict in Ukraine.

Specifically, the RCNM is prioritizing children, women with children, older people, and people with health problems. Due to their age, medical conditions or family circumstances, lack of financial means and inability to work these groups of people have been identified as those who are the most in need of humanitarian assistance from the National Society. 

National Society role in the national response

The RCNM is an auxiliary to the government. As part of its leading role in the national response framework (since 2015) RCNM coordinates all humanitarian activities in the country targeting migrants, asylum seekers, and refugees, including persons fleeing Ukraine.

Operations are planned in cooperation with Ministry of Labor and Social Policy as the leading national body on migration, the Ministry of Interior, the Ministry of Foreign Affairs, the Directorate for Protection and Rescue, and the Crisis Management Center. RCNM is part of the Crisis Committee of the State and the Central Government body for Crisis Management. RCNM is part of the Interdepartmental Group on Migration policy initiated by the Government of North Macedonia.

State institutions and other NGOs fully recognize the key role of the Red Cross, the capacities that are at its disposal. The RCNM is an equal member in all decision-making bodies on this issue.

Key areas of scale-up and strength

The City Red Cross of Skopje and the municipal organizations of the Red Cross registered large numbers of displaced people from Ukraine and there has been a corresponding large increase in demand for services to which the NS has responded by greatly expanding its material and technical resources. There has been an increased engagement of volunteers and professional staff in relation to the operation. Involved Red Cross units have strengthened their skills and capacity in providing psychological support to the people fleeing the conflict in Ukraine, as well as staff and volunteers engaged in the response. Logistics and warehousing units (2 warehouses) have been handling greatly increased volume due to the increased need for delivery of emergency supplies and cash to the affected population.

The City Red Cross of Skopje has extensive experience in implementing activities to support refugees and migrants in reception centres. Through the Global Route-based Migration Programme and the previous humanitarian crisis, the NS has also extensive experience with different types of HSPs, including mobile units, as well as activities to support evacuees from Afghanistan and coordination of the support for people from Ukraine. Other Red Cross units in the country have considerable volunteer capacity and mostly 2-3 employees, but limited experience in working with displaced people. Thus more coordination, training and retraining is required to enhance their response capacity.

Areas of new / additional capacities developed

The National Society has built expertise in the delivery of cash and voucher assistance (CVA), which is a major part of its response to the Ukraine crisis. The RCNM has also taken a leadership role as the only organization that provides structured psycho-social support and operates child friendly spaces. The NS has also taken on an important role in supporting people fleeing the conflict in Ukraine in accessing health services in the country.

The National Society has improved its expertise in needs assessment, using new data collection tools such as KoBo, as well as focus groups. A KoBo form has also been created for registration of people fleeing the conflict in Ukraine.

The RCNM has increased its coordination capacities and strengthened its cooperation with governmental institutions through its participation in coordination meetings with the government and a special group founded by the Ministry of Interior supporting people fleeing Ukraine.
